#### Safeguarding and Welfare Requirement: Key Person

Each child must be assigned a key person. Their role is to help ensure that every child's care is tailored to meet their individual needs, to help the child become familiar with the setting, offer a settled relationship for the child and build a relationship with their parents

# 4.1 The role of the key person and settling-in

#### **Policy statement**

We believe that children settle best when they have a key person to relate to, who knows them and their parents well, and who can meet their individual needs. We are committed to the key person approach which benefits the child, the parents/carers, the staff and the setting. It encourages secure relationships which support children to thrive, give parents/carers confidence and make the setting a happy place to attend or work in.

We want children to feel safe, stimulated and happy in the setting and to feel secure and comfortable with our staff. We also want parents/carers to have confidence in both their children's well-being and their role as active partners with our setting. We aim to make our setting a welcoming place where children settle quickly and easily because consideration has been given to the individual needs and circumstances of children and their families.

The key person role is set out in the Safeguarding and Welfare Requirements of the Early Years Foundation Stage. Each setting must assign a key person for each child. The procedures below set out our model for developing our key person approach that promotes effective and positive relationships for children who are in our setting.

#### **Procedures**

- We allocate a key person before the child starts.
- In our setting a home visit is carried out before all children start, this is completed by a manager and the key person
- The key person is responsible for providing an induction for the family and for settling the child into our setting.
- The key person offers unconditional regard for the child and is non-judgemental.
- The key person works with the parents/carers to plan and deliver a personalised plan for the child's well-being, care and learning.

- The key person acts as the key contact for the parents/carers and has links with other carers involved with the child, such as a childminder, and co-ordinates the sharing of appropriate information about the child's development with those carers.
- The key person is responsible for developmental records and for sharing information on a regular basis
  with the child's parents/carers to keep those records up-to-date, reflecting the full picture of the child in
  our setting and at home.
- The key person encourages positive relationships between children in her/his key group, spending time with them as a group each day.
- We promote the role of the key person as the child's primary carer in our setting, and as the basis for establishing relationships with other adults and children.
- We provide a secondary key person so the child and the parents/carers have a key contact in the absence of the child's primary key person

## Settling-in

- Before a child starts to attend our setting, we use a variety of ways to provide his/her parents/carers
  with information. These include written information (including our prospectus and policies), displays
  about activities available within the setting, information days and evenings and individual meetings with
  parents. We also complete relevant forms in advance with the parents/carers and explain our policies
  and procedures with particular focus on policies such as safeguarding and our responsibilities under
  the Prevent Duty.
- During the half-term before a child is enrolled, we provide opportunities for the child and his/her parents/carers to visit the setting.
- We allocate a primary key person to each child and his/her family before she/he starts to attend; the
  key person welcomes and looks after the child and his/her parents at the child's first session and
  during the settling-in process.
- We perform home visits which are completed by a manager and the child's key person to ensure all relevant information about the child can be made known.
- We use pre-start visits and the first session at which a child attends to explain and complete, with his/her parents/carers, the child's registration records.
- When a child starts to attend, we explain the process of settling-in with his/her parents/carers and jointly decide on the best way to help the child to settle into the setting.

- Younger children will take longer to settle in, as will children who have not previously spent time
  away from home. Children who have had a period of absence may also need their parent/carer to be
  on hand to re- settle them.
- We judge a child to be settled when they have formed a relationship with their key person; for
  example, the child looks for the key person when he/she arrives, goes to them for comfort, and
  seems pleased to be with them. The child is also familiar with where things are and is pleased to see
  other children and participate in activities.
- When parents/carers leave, we ask them to say goodbye to their child and explain that they will be coming back, and when.
- We recognise that some children will settle more readily than others, but that some children who
  appear to settle rapidly are not ready to be left. We expect that the parent will honour the
  commitment to stay as long as it takes for their child to settle without them
- We do not believe that leaving a child to cry will help them to settle any quicker. We believe that a child's distress will prevent them from learning and gaining the best from the setting.
- We reserve the right not to accept a child into the setting without a parent or carer if the child finds it distressing to be left. This is especially the case with very young children.
- Within the first four to six weeks of starting, we discuss and work with the child's parents to begin to create their child's record of achievement.

#### The progress check at age two

- The key person carries out the progress check at age two in accordance with any local procedures that are in place and referring to the guidance A Know How Guide: The EYFS progress check at age two.
- The progress check aims to review the child's development and ensures that parents have a clear picture of their child's development.
- Within the progress check, the key person will note areas where the child is progressing well and identify areas where progress is less than expected.
- The progress check will describe the actions that will be taken by us to address any developmental concerns (including working with other professionals where appropriate) as agreed with the parents/carers.
- The key person will plan activities to meet the child's needs within the setting and will support parents to understand the child's needs in order to enhance their development at home.
